1. **An application must be completed and returned to H&H Federal Credit Union, P.O. Box 1187, Stinnett, 79083 by March 5, 2010.**
2. Must be a member of H&H Federal Credit Union. The student must have a savings account in their name on or before March 5, 2010. Call 1 (800) 882-1740 for information.
3. Must be a graduating senior from one of the High Schools serviced by H&H Federal Credit Union either in Hutchinson, Hansford, Moore, or Carson counties in Texas.
4. One scholarship will be awarded to one individual from each of the schools which H&H Federal Credit Union services.
5. An overall high school grade point average of 3.0 is required therefore; a copy of the applicant's overall high school transcript must accompany the application when it is returned. You must take a minimum of 12 accredited college hours. At the end of the fall semester of college, a transcript must be submitted in order to receive funds for the spring semester. You must maintain a 2.5 grade point average in college in order to receive the scholarship funds.

Scholarship applications will be extended only upon request and will be judged by the H&H Federal Credit Union's Scholarship Committee. If management cannot make a presentation to the recipient at their school, then recipient should be willing to come to the offices of H&H Federal Credit Union for a Scholarship presentation and photo so information may be sent to their local media.
